BHS Student Drivers and Parents: 2011 – 2012 School Year

The Batesville High School Handbook contains the policy pertaining to “Student Automobiles.” This policy begins with the statement “Permission to drive to school will be granted...” This statement is important in the realization that driving to school is a privilege and not a right. The school system has the right to grant or remove this privilege.

In order to earn the privilege of driving to school, a student must fill out a form that verifies the following: 1) the student has complied with state requirements for operating a vehicle; 2) liability and property damage insurance exists on the car[s] to be driven to school; and 3.) parental approval for the student to drive to school. Once this form is submitted, the student is rewarded with the granting of permission to drive to school. A parking permit is issued to verify the granting of permission. A parking permit costs \$5.00. ALL STUDENT drivers must complete a driver registration form. Last year’s form and tag will NOT work for this year.

Every student driver must have the NEW TAG displayed on their vehicle by Wednesday, August 17th.

Once the student has been granted permission to drive to school, and has displayed the parking permit on the rearview mirror indicating such, it is the responsibility of the student to handle this privilege appropriately. The following are examples of actions that could be grounds for the removal of a student’s driving privilege: 1) failure to park in an orderly manner in the areas assigned by the school. No student is to park in the front of the school without prior administrative permission; 2) loitering in cars/parking lot at any time; 3) driving in an unsafe or reckless manner on school property; 4) excessive tardies to first period; 5) failure to have a vehicle properly registered with the main office; 6) parking in non-student areas, including the primary school and central office spaces or parking in any area not marked by the proper yellow lane marks, 7) truancy from school, and 8) failure to have a parking permit displayed on the rearview mirror. The Batesville City Police and faculty/staff members will aid us in maintaining an orderly parking lot. A citation can be issued and/or a car towed for driving/parking violations.

NOTE: Students who drive to school, but fail to secure a parking permit, will be subject to disciplinary action, including but not limited to, suspension of driving privileges indefinitely and towing of the vehicle failing to display a parking permit. **REMEMBER: Be a SAFE driver!**

Parent Request Form for Student Driving Privilege 2011-2012

The Privilege of driving to school will be granted by the administration upon the completion of this form and the payment of \$5.00 for the purchase of a parking permit and presentation of a copy of a valid drivers license.

Refusal by any of these individuals to provide or allow access to a motor vehicle on school premises at the time of a request to search the motor vehicle shall be cause for termination without further hearing of the privilege of bringing a motor vehicle on school premise.
