Registration Form/Fees:

As a reminder, one half of the registration fees are due by **April 16, 2010** and one half is due by **June 30, 2010**. You may pay the full amount at time of registration. Please complete one registration form per student and return it with your registration fee to the school office.

Registration Fees if paid in full by June 30, 2010:

Kindergarten Half Day	\$110.00 per student
Kindergarten Full Day	\$220.00 per student
Grades 1- 8	\$220.00 per student

Late Registration Fee Notice: *An additional \$30.00 fee per student will need to be paid if registration fee balance is paid after June 30, 2010.*

Registration Fees if paid after June 30, 2010:

Kindergarten Half Day	\$140.00 per student
Kindergarten Full Day	\$250.00 per student
Grades 1- 8	\$250.00 per student

Tuition Assistance Program:

For the 2010-2011 school year, the tuition assistance program will be available for families that are experiencing financial challenges. The administration of this service will be through Private School Aid Service (PSAS). PSAS serves as a third party to help us understand the financial need of a family. The processing fee is \$20.00 per application that is to be paid directly to PSAS with your completed application. If you are unable to pay the processing fee, please include a note with your application that you wish for St. Louis Parish to assist with your fee. **Applications are due to PSAS by April 16, 2010.** Parents need to send the application directly to PSAS (the address is on the application). Tuition assistance awards will be deducted from either tuition payments due or your monthly automatic withdrawal will be adjusted.

May 23	Parents will be notified of Tuition Assistance Awards
June 30	Remainder of unpaid registration fee is due Tuition payments due for Full Payment option First semester Tuition payments due for parents paying by semester
July 5	Monthly Automatic Debit payments begin and annual fee will be withdrawn for parents choosing 12 Month payments
August 5	Monthly Automatic Debit payments begin and annual fee will be withdrawn for parents choosing 10 Month payments
November 30	Second Semester Tuition payments due by parents paying by semester
